Master of Public Health (MPH) with a concentration in Global Health

The **MPH with a concentration in Global Health** trains students to apply global health principles to both domestic and international challenges, with a focus on identifying and addressing health inequities. The increasing interconnectedness of the world requires professionals educated from a global perspective.

This global health program leverages a transdisciplinary approach preparing technically skilled professionals to overcome challenges in continually shifting and culturally vibrant landscapes. All full-time students in this program can expect to complete their coursework in two years (over a total of 6 semesters).

#### MPH with a concentration in Global Health: The Accelerated Track

In addition to the two-year regular MPH track, we offer an accelerated track for exceptional applicants to complete the degree in 3-4 semesters. This track is designed for applicants who:

- Have a strong relevant professional background
- Have a strong academic track record to succeed in an intensive route

### **PROGRAM QUALIFICATIONS**

Those interested in applying must apply through SOPHAS (sophas.org), the centralized application service for public health. Minimum requirements include:

- 3.0 GPA •
- Official university/college transcript
- Current resume/CV (not exceeding 3 pages)
- Written statement of purpose (career goals) .
- 3 letters of recommendation
- English proficiency exam (international applicants)
